5<sup>th</sup> Notice of Teaching Arrangement for the 1<sup>st</sup> Semester of Academic Year 2021/2022

This notice is very important for all undergraduate students.

Please read it immediately and carefully!

Dear Undergraduate Students,

We would like to announce that all teaching activities can resume normal and classes will mainly be arranged on a face-to-face teaching basis from <u>7 October 2021 (Thursday)</u>. Please find below the detailed teaching arrangements for the 1<sup>st</sup> semester of academic year 2021/2022:

# 1. Teaching Mode

All classes will mainly be resumed on a <u>face-to-face teaching basis from 7 October</u> <u>2021 (Thursday)</u>. Students should pay close attention to the Announcement of the Special Webpage against Epidemics of the Health Bureau of the Macao SAR (<a href="https://www.ssm.gov.mo/apps1/PreventCOVID-19/en.aspx#clg17610">https://www.ssm.gov.mo/apps1/PreventCOVID-19/en.aspx#clg17610</a>).

If students are <u>not permitted to enter Macao by the Macao SAR Government, or</u> <u>being identified in Red Code or Yellow Code Zones by the Macao SAR Government,</u> the University will arrange online classes for these students.

Students are required to attend the face-to-face classes on campus during the classroom teaching period and the requirement of 80% class attendance on the said period will be applied as normal.	These students' class attendance will not be considered but they will still be required to meet the participation requirements advised by the teachers concerned.



According to the advice from the Education and Youth Development Bureau (the DSEDJ), starting from 25 October onwards, staff and students of tertiary education institutions in Macao are required to present the proof of having received at least the first dose of COVID-19 vaccine or the proof of a negative nucleic acid test result obtained within 7 days before entering the University. After resumption of face-to-face classes, students who are eligible for face-to-face classes but do not meet the above requirements will be deemed as <u>ABSENT without LEAVE</u>. According to General Rules Governing Bachelor's Degree Programmes, student who is <u>ABSENT without LEAVE</u> from a course for more than 20% of the teaching period in the aggregate will NOT be allowed to take the final examination and will received a failing grade.

In consideration of the above, the Health Bureau (the SSM) will carry out collective vaccination work at the University on 5 October with details as below and it will be free of charge.

Date: 5 October 2021Period: 09:00 – 17:30

Location: Training Hall, Sports Complex (N8)

 Type of Vaccine: mRNA vaccine (BioNTech) or inactivated vaccine (Sinopharm CNBG Beijing)

Students who are interested in receiving the vaccine must make an online appointment at <a href="https://app.ssm.gov.mo/sccovidvacbook/Booking?lang=en">https://app.ssm.gov.mo/sccovidvacbook/Booking?lang=en</a> by 3 October 2021. Please select the University of Macau as the vaccination site and choose the type of vaccine when making the appointment online. The University urges students to get the COVID-19 vaccine at your earliest convenience to protect yourselves.

You can attend the face-to-face classes only if a "Green Permit" is obtained. If you obtain a "Red Note" on any given day, you will NOT be allowed to attend any face-to-face class during that day.
