Discontinued and inactive students are required to make up the check-out procedures by completing the Check-Out Form (REG/Form/002) and clear all outstanding items with the departments concerned before applying for re-admission of study. However, they are not required to obtain approval from the Dean of the academic unit concerned for the check-out.
- Students who cannot complete this application in person may authorize a representative to complete it on his/her behalf by completing and signing
 the Authorization on the back page of this application form. The authorized representative must submit this application form together with the I.D.
 copies of both parties.
- 4. If students leave the University in the course of study without going through the check-out procedures, no official document (such as testimonial, transcript or graduation certificate) will be issued.
- 5. All resuming and re-admitted students should pay their tuition fees according to the tuition schemes of the resuming/re-admitted year and are required to check the study plan with the general office of the academic unit concerned.
