 - 申請覆核物理科考試成績之費用為澳門幣 50 元。
 - 覆核成績之結果將最遲於申請覆核成績截止日期後五個工作天內以電子郵件通知申請人。
 - 經主考覆核之成績為該科之最終成績。本校將不再受理考生任何上訴申請。
 - 在任何情況下，大學不會公開考生之入學考試試卷及其答題內容。
2. 覆核成績是指由有關科目之主考覆查試題每部份之分數及總分是否計算無誤，及所有答案是否已獲評分。

NOTE

1. For candidates who would like to recheck his/her UM Admission Examination Result (Physics), please follow the below procedure:
 - Candidates should complete the application form for rechecking Admission Examination results (REG/Form/040) and submit it to the Registry, University of Macau in person by 29 May 2017. Late applications will not be handled.
 - MOP\$50 is charged for rechecking of the result of Physics subject.
 - The rechecked result will be notified by email within 5 working days at most after the application deadline.
 - The rechecked results will be served as the final decision. Further request for rechecking will not be accepted.
 - Under no circumstances will the University disclose the examination papers and answers of a candidate.
2. The Chief Examiner of concerned subject will recheck the scores for each section, the total score of the answer sheet and any written scripts completed for the examination.
